ADMISSION GUIDELINES FOR ASSOCIATE DEGREE HOLDERS.

Dear Sir.

I am directed to draw your kind attention to HED Notification No. SO (C-IV)/ HED/10-0/Associate Degree Launching/2020, dated Sep. 16, 2020, whereby 2-years Associate Degree Program was launched in all non-BS colleges of Khyber Pakhtunkhwa effective from the start of academic session 2020-21. The said notification was followed by letter No. SO (C-IV)/ HED/10-0/Associate Degree/2020, dated Oct. 12, 2020, to advise all affiliating universities to prepare a uniform structure for both BS and AD programs in terms of admission requirements, schemes of studies, credit hours, transfer of credits, evaluations, promotion and pathway for further education.

O2. Currently 4th semester of Associate Degree is going on in Non-BS Colleges of KP where students will complete Associate Degree. Same students will further join BS Program in 5th semester from Fall 2022 as no M.A/M.Sc. 16-year education will be offered in future to these students. Universities have to make a policy for merging of A.D/B.A/B.Sc Student with the B.S 4 Year Program. All Vice Chancellors are therefore requested to make proper policy through thei. Academic Council on immediate basis to avoid any issue for students in this regard.
